

#### **GENERAL QUESTIONS**

#### 1. (Q) Will I receive a commission on value-added programs?

A No. These programs are not insurance. Instead, they're automatically added to our Medicare supplement policies. No additional commission is payable.

#### 2. (Q) What's free and what's not?

A There's no cost for policyholders to use the EyeMed, Amplifon and Mutually Well programs. However, policyholders who choose to purchase the optional Mutually Well gym membership will incur a \$25 monthly fee plus applicable taxes.

#### 3. (Q) Who is eligible for these programs?

A All Mutual of Omaha or affiliate company Med supp policyholders have access to the EyeMed, Amplifon and Mutually Well programs where available.

#### QUESTIONS ABOUT MUTUALLY WELL

- 4. (Q) How do people join the Mutually Well program?
  - A Med supp policyholders can join Mutually Well online at MutuallyWell.com or on the mobile app. They also can join by calling Tivity Health at 833-574-6105. Your clients will need to provide their name as it appears on their Medicare card, their date of birth and their ZIP code in order for Tivity Health to validate whether they have a Mutual of Omaha Medicare supplement policy.

#### 5. (Q) What if the information they provide doesn't match their Medicare card?

- A They will be directed to call policyowner services for help.
- 6. (Q) Can they join Mutually Well at a local gym or fitness location?
  - A No. They must join online, on the mobile app or by calling Tivity Health.
- 7. (Q) Can my clients get more information before deciding whether to join the program?
  - A Yes. The website, MutuallyWell.com, provides details about the program and allows your clients to see a map of participating locations in their area. Once they decide to join, they'll be able to print discount coupons and purchase the optional gym membership.

#### 8. (Q) How do people pay for the Mutually Well gym membership?

A Credit card is the only method of payment for the gym membership. Tivity Health accepts Visa, MasterCard and American Express. Gym members have the option to pay on a month-by-month basis or set up an automatic, recurring payment. They also can stop and restart their membership at any time.

9. 🭳	Can Mutually Well gym members use multiple fitness facilities?
A	Yes. For example, a Mutually Well gym member may choose to work out in one facility and attend classes in others. Gym members have access to any facility in Tivity Health's Prime Fitness Network.
10. 🭳	What fitness facilities are included in the network?
A	Tivity Health's Prime Fitness Network includes both national chains and local options. The website and mobile app provide an up-to-date listing of fitness locations for registered Mutually Well members.
11. 🤦	Can spouses and family members join Mutually Well?
A	No. Mutually Well is only offered to Mutual of Omaha or affiliate company Med supp policyholders. Family gym memberships are not available.
12. 🭳	Who should my clients call if they have questions about Mutually Well?
A	They should call Tivity Health at 833-574-6105 with questions about the program.
