BONUS CAMPAIGN GUIDELINES

- Qualifying sales include National General Underwritten and Open Enrollment Medicare Supplement Insurance issued plans submitted July 1, 2020, through December 31, 2020.
- Plans must be issued and in force for a minimum of two months, with premium paid, to qualify for the bonus.
- At least three plans must be sold during a month to receive the bonus. Once the requirements have been met on at least 3 sales for a month, the bonus will apply to all sales made that month.
- Only Direct Paid Agents are eligible to earn qualifying bonuses, Licensed Only Agents (LOA) do not qualify for this bonus program.
- Agents must be appropriately licensed and appointed with the applicable underwriting company (National Health Insurance Company, Integon National Insurance Company, and/or Integon Indemnity Corporation) on the dates the sales are made and the bonus is paid.
- Bonus payments will be made to the same agent/agency to whom the applicable commissions related to the sales of the National General Medicare Supplement Insurance plans will be paid.
- Bonus money will be considered taxable income and reported on recipients' FORM 1099-MISC.
- Bonuses will be paid no more than 90 days following the end of the campaign.
- All usual commission and persistency rules apply.
